THE CITY OF CONROE HAS THE RIGHT TO REGAIN THE TITLE TO THE PROPERTY IF CU DOES NOT MEET THESE TIME LIMITS OR DOES NOT CONTINUE TO OPERATE AS A NON-PROFIT SERVING THE HOMELESS. THIS REVERSIONARY INTEREST EXPIRES ON DECEMBER 31, 2039. CU ESTIMATED THAT THE VALUE OF THE LAND DONATION WAS \$217,800, WHICH IS INCLUDED IN WITH DONOR RESTRICTIONS. THE SITE IS CALLED MIRACLE CITY.

CU PLANS FOR THE SITE TO INCLUDE AN INNOVATIVE, TRANSFORMATIONAL COMMUNITY CONSISTING OF TRANSITIONAL HOUSING, SUPPORT SERVICES, AND EMPOWERMENT OPPORTUNITIES. THE FIRST BUILDING IN MIRACLE CITY, THE EMPOWERMENT BUILDING, WAS COMPLETED IN APRIL 2022. IT IS A STEEL FRAME, 5,500 SQUARE FOOT BUILDING THAT HOUSES THE CHOP AND FRESH START EMPOWERMENT CENTER AS WELL AS ADMINISTRATIVE OFFICES. ITS TOTAL COST OF APPROXIMATELY \$1,130,000 INCLUDES CONSTRUCTION COSTS PLUS PERMITS, UTILITY CONNECTIONS, ARCHITECTURAL FEES, ENGINEERING, LIABILITY INSURANCE, BANK FEES AND SITE WORK. AS OF DECEMBER 31, 2022 AND 2021, RESTRICTED CASH TOTALING \$121,024 AND \$693,158, RESPECTIVELY, WAS AVAILABLE FOR FUNDRAISING, DESIGN, DEVELOPMENT, AND CONSTRUCTION OF MIRACLE CITY.
